I have felt burdened to share some information and thoughts with you from the periodical *Zion's Fire*. Their material is always timely, relevant, insightful, and Biblical. I look forward to every issue because much of their content has to do with end time events and helping their readers better understand the times in which we live. The founder of the ministry is Marvin Rosenthal, author of the book *The Pre-Wrath Rapture of the Church*, which I also highly recommend. His son, David Rosenthal, is one of the principal writers and offers information as to why current events are so important for Christians to follow in light of Biblical prophecy. It is a must read!

What I am about to paraphrase is an article written by David in this year's March/April issue entitled: "Are we Hearing the Hoofbeats of the Four Horsemen?" Quotes from David will be in this color, normal print black color will be my paraphrase from the article, and personal comments will be in this color:

Many have been asking if the Covid-19 pandemic is part of Daniel's 70th week prophecy. Personally, I don't believe it is but that there is a spiritual battle taking place. God is using this pandemic to awaken the body of Christ as to the soon coming return of our Lord Jesus Christ and the fierceness of the spiritual battle that is taking place even before "the beginning of sorrows" when the presence of the four horsemen will be even more apparent.

Some believe world governments are simply responding at face value to the threat of a deadly new coronavirus...government-mandated restrictions and the complete closure of businesses and institutions as absolute

necessities to reduce the threat to public health and safeguard society. Others believe the Federal Reserve is using the situation to restructure massive global debt and address concern over rising viable crypto-currencies, and by China's implementation of a digital currency in an attempt to replace the dollar with the Chinese yuan as the world's reserve currency. The U.S. and nations of the G20 are on the verge of becoming cashless countries. Interest rates in the U.S. are near zero. If they move into negative territory, as in Japan, banks will begin to charge consumers a percentage fee to keep money in the bank. If people begin to pull their money out to avoid fees and for safe keeping, banks will move to a digital currency and control its acceptable use through a central financial authority. This will be yet another impingement of our privacy rights and civil liberties.

Others believe the real impetus for the economic shutdown is a broader U.S. war with China. This war is fought through trade, technology, and telecommunications. All three areas are pivotal to our economy and national security. Many believe it is all part of an ideological war being waged by globalist elites such as Bill Gates against the rising tide of nationalism. For decades, Gates has funded the development of vaccines for mass global distribution. Today, he is at the forefront of **ID2020**, a combined effort...to implement a mandatory digital identity for every man, woman, and child on Planet Earth through the use of biometric technology. Through the distribution of billions of dollars, Gates and his foundation now wield an astonishing level of power and influence on global agencies...two of the main sources of data used to support the coronavirus pandemic models for U.S. government infections and mortality projections...have been the University of Washington...and The Imperial College of London...According to public sources, over the past two decades, The Bill and Melinda Gates Foundation has provided **more** than **\$1.3** billion in combined funding for these institutions.
